Re: City of Menasha Alcohol Operators License Application

Mr. Dustin Champine

I have reviewed your application for an alcohol operator's license with the City of Menasha and in doing so it was discovered that there were several issues with your alcohol operator's license application. The first issue is with question #5 you indicated that you had been convicted of a law, statute or ordinance pertaining to the use or sale of alcohol or illegal drugs, in your explanation on the back of the application you neglected to add an arrest and conviction for Underage Alcohol Violation that you were arrested for on November 17, 2006 and convicted of January 3, 2007 in Outagamie County. You also neglected to include an arrest and conviction for Possession of Drug Paraphernalia and THC which occurred in April 2003. The background investigation that I conducted revealed the following arrest and convictions for alcohol and drug related offenses that occurred within the last 7 years. Also included in this background investigation were arrest and convictions for charges that reflect your lack of cooperation with law enforcement officials.

The first arrest and convictions that I looked at had an arrest date of September 11, 2004 and with a conviction date of June 22, 2005. These offenses occurred in Forest County, WI and they were as follows: Possession of THC, Possession of Cocaine and two counts of Bail Jumping.

The next arrest and conviction also occurred in Forest County with an arrest date of April 12, 2004 and a conviction date of January 19, 2005. It was a charged of Resisting or Obstructing an Officer.

The next offense that I looked at was the Underage Alcohol Violation that occurred in Outagamie County that you had failed to mention in your application. This arrest occurred on November 17, 2006 with a conviction date of January 3, 2007.

Since you have been convicted of two or more offenses on separate incidents within the last 7 years which are directly related to the license for which you applied for, under Menasha City Guidelines #3 you do not qualify for an operator's license.

Furthermore, since you were convicted of two or more offenses on separate incidents within the last 7 years which are directly related to the license you applied for, under Menasha City Guidelines #2 you do not qualify for an operator's license.

Additionally since you did not provide accurate information on the application by omitting that you had been charged with an alcohol offense, under guideline #4 you are not eligible for an operator's license.

Based on these circumstances I will be denying your application for an alcohol operator's license with the City of Menasha.

I would like to further advise you that you may appeal this decision, by contacting the Menasha City Clerk's Office at (920)967-3603 within 30 days of this denial to request an appeal before the common council. At this appeal you have the right to be represented and to be heard and to present evidence in favor of granting the license and to rebut the evidence presented in opposition to the granting of this license at a hearing held within 45 days of the filing of such appeal.
