RE: Purchase of Dive Suits

During the 2015 budget process, we requested \$40,000 to purchase all divers their own masks, additional suits and other personal protective equipment. \$20,000 was approved for expenditure this year. In January, we purchased all divers their own masks and would like to move forward with purchasing additional suits with the remaining budgeted funds.

I've attached copies of quotes from four different vendors. Please note the quotes attached are to purchase eight suits. However, there is only enough money left in our budget to purchase six dry suits. I am requesting permission to purchase six dry suits, gloves and hood liner from Dive Rescue International for a cost not to exceed \$11,013.48.
