We certify that the attached Tabular Statement of Votes Cast, canvassed and prepared by us, is correct and true as compiled from the original returns made to the City Clerk.


- We further determine and certify that the following persons received the greatest number of votes for the respective office for which each was a candidate on February 16, 2016.


The total number of votes cast for Mayor was 2,140, of which



Present: Members Greg Keil, Sue Seffker (for Thomas Stoffel) and City Clerk Deborah A. Galeazzi




