Discussion Topic: Addressing locally undesirable land uses.

Pre-meeting walking tour –we will have a special walking tour from 5:30pm - 6:15pm of the Trochinski farmstead in the Town of Nepeuskun. This tour will highlight energy savings and generation options for the farmstead including a 12 Volt photo voltaic system on the barn that generates electricity for their home. Don't miss it!
