

CHAPTER 2

Enforcement of Ordinances; Issuance of Citations

SEC. 1-2-1 METHOD OF ENFORCEMENT.

The City of Menasha hereby elects to use the citation method of enforcement of ordinances.

- (a) **AUTHORITY.** Pursuant to the authority of Sec. 66.119, Wis. Stats., as amended, the City of Menasha hereby elects to adopt and authorize the use of a citation to be issued for violations of ordinances, including ordinances for which a statutory counterpart exists.
- (b) **CITATION.** The form of the citation is hereby prescribed as found in Sec. 66.119(1)(b), Wis. Stats., as amended, which is incorporated herein by reference.
- (c) **SCHEDULE OF CASH DEPOSITS.** A schedule of cash deposits is established by Section 1-2-2, as amended.

SEC. 1-2-2 FORM OF CITATION.

The form of the citation to be used by the City is on file in the City Clerk's office and is adopted by reference as though fully set forth herein.

SEC. 1-2-3 ISSUANCE OF CITATION.

- (a) Any law enforcement officer may issue citations authorized under this chapter as well as any other part of the City of Menasha Code.
- (b) The Fire Chief or his/her designee is authorized to issue citations under SEC. 5-2, 5-3 and 11-7 of the City of Menasha Code.
- (c) The Community Development Director or his/her designee is authorized to issue citations under SEC. 8-1, 8-2, 11-7, 13-1, 13-2, 13-3, 15-1 and 15-2 of the City of Menasha Code.
- (d) The Public Works Director or his/her designee is authorized to issue citations under SEC. 6-2, 6-4, 8-1 and 8-3 of the City of Menasha Code.
- (e) The Code Enforcement Officer may issue citations authorized under this chapter as well as any other part of the City of Menasha Code.
- (f) The designations of paragraphs (b) through (d) of this Chapter are in addition to the authority under Section (a) of this Chapter. Nothing shall be construed to limit the authorization of a law enforcement officer to issue citations for any of these violations.
- (g) No citation may be issued under paragraphs (b) through (d) without the advice and consent of the City Attorney.
- (h) Community Service Officers are authorized to issue citations under SEC. 7-1, ~~10-1-20~~—~~10-1-38~~, 10-4, 11-3, and 11-7 of the City of Menasha Code.

SEC. 1-2-4 NONEXCLUSIVITY.

- (a) **OTHER ORDINANCE.** Adoption of this Chapter does not preclude the Common Council from adopting any other ordinance or providing for the enforcement of any other law or ordinance relating to the same or other matter.

- (b) **OTHER REMEDIES.** The issuance of a citation hereunder shall not preclude the City or any authorized officer from proceeding under any other ordinance or law or by any other enforcement method to enforce any ordinance, regulation or order.
