NOTICE TO ELECTORS: THIS BALLOT MAY BE INVALID UNLESS INITIALED BY 2 ELECTION INSPECTORS. IF CAST AS AN ABSENTEE BALLOT, THE BALLOT MUST BEAR THE INITIALS OF THE MUNICIPAL CLERK OR DEPUTY CLERK.

To vote for the candidate of your choice, completely darken the oval to the LEFT of the candidate's name like this ●. To vote for a person whose name does not appear on the ballot, write the person's name on the line provided and completely darken the oval to the LEFT of the person's name like this ●.

PRESIDENTIAL PREFERENCE VOTE

In the Presidential Preference Election, if you vote more than once, your vote will not be counted.

To vote for the candidate of your choice, or for the uninstructed delegation, completely darken the oval to the LEFT of the candidates' name or to the LEFT of "Uninstructed Delegation", like this ●. To vote for a person whose name does not appear on the ballot, write the persons name on the line provided and completely darken the oval like this ●.

Darken ONE oval ONLY for this office ONLY within the party of your choice: YOU HAVE 1 OF 3 OPTIONS:

Express your preference for one of the persons whose name is printed on this ballot; or Vote for an uninstructed delegation from Wisconsin to the national convention of the party of your choice; or Write in the name of another person to become the Presidential candidate of the party of your choice.
